ARTICLE I — NAME

The name of the corporation is WorldX Innovation, Inc.

ARTICLE II — REGISTERED AGENT AND OFFICE

The directors shall be elected annually by the stockholders entitled to vote. Each director shall hold office until the next annual meeting of stockholders and until his or her successor has been duly elected and qualified.
